

Young woman who offers self as sacrificial lamb to be buried alive

Young Woman Who Offers Self As Sacrificial Lamb To Be Buried Alive

Princess Inikpi was a beautiful and intelligent young woman whose selfless sacrifice saved the Igala people from doom.

She was the only daughter of her parents, Atah Ayegba Oma Idoko and Queen Omele.

During the 15th and 16th centuries, the Igala Kingdom faced conflict with the Benin Kingdom, one of their strongest adversaries.

Benin warriors persistently attacked Igala territory, seeking to annihilate its people.

The Bini warriors employed various tactics, including poisoning streams, launching sudden attacks day and night, and besieging farmlands.

The Igala people lived in constant fear, unable to tend to their farms or fetch water from the streams.

In response, the chiefs consulted the oracle, which proclaimed that the only remedy for the kingdom's safety and victory in war was for the king to bury his beloved daughter, Inikpi, alive.

The king had four sons — Akogu, Agada, Eleme, and Ohiemi Obogo — and Inikpi was his only daughter. He cherished Inikpi deeply, often keeping her close in the palace.

Distraught, the king abstained from eating or drinking for days. He pleaded with the oracle to accept slaves, but it insisted on royal blood—specifically, Inikpi's.

Noticing her father's distress, Princess Inikpi inquired persistently until, on the seventh day, the king revealed the oracle's demand to save the Igala land and its people.

Understanding her father's sorrow, Inikpi resolved to offer herself. Her decision brought mourning throughout the kingdom, especially from her mother, Omele.


On the appointed day,

Inikpi journeyed to the bank of the River Niger at Ida, where she was buried alive alongside nine virgin slaves who would assist her in the afterlife.

Following the sacrifice, as the Bini warriors advanced, they observed the entire Igala land ablaze and retreated, believing there was no need to attack a town already engulfed in flames. This deception was attributed to Inikpi's blood, according to historical accounts.

Inikpi's sacrifice brought enduring joy, peace, and security to the Igala Kingdom, liberating its people from the threats of surrounding enemies and ensuring victory in wars.

Inikpi remained a virgin throughout her life, and her courageous act inspired many parents to name their daughters after her. A statue honoring her stands at Ega in the Idah market in Kogi State.

CDS Vows To Arrest Culprits Behind Death Nigeria's Of Army Commander, Officers In Delta

Rollowing the killing of troops of the Nigerian Army deployed for a peacekeeping mission to two warring communities in Bomadi LGA of Delta State, including the commanding officer, two majors, one captain, and 12 soldiers, the Chief of Defence Staff (CDS), General CG Musa, has ordered the immediate arrest and investigation of all those involved.

The Director, Defence Information, Brigadier General Tukur Gusau, confirmed the killing of the military personnel on Saturday.

He said, "The troops of 181 Amphibious Batallion, Bomadi Local Government Area of Delta State, while on a peace mission to Okuoma community in Bomadi LGA of Delta State were surrounded by some community youths and killed on Thursday, March 14, 2024.

"The unfortunate incident occurred when the troops responded to a distress call after the communal crisis between the Okuama and Okoloba communities, both in Delta State.

"The reinforcement team led by the commanding officer was also attacked, leading to the deaths of the commanding officer, two majors, one captain, and 12 soldiers.

"The Chief of Defence Staff (CDS), General Christopher Gwabin Musa, has directed the immediate investigation and arrest of those involved in the heinous crime.

"The occurrence has been reported to the Delta State Government.

"However, the military remains focused and committed to its mandate of maintaining peace and security in the country.

"So far, a few arrests have been made while steps are being taken to unravel the motive behind the attack.

Insecurity: Groups To Submit Nigerian Situation Report Before UK Govt, Parliament

wo Nigerian charity organizations based in the United Kingdom (UK) will submit a report on the current security situation in the country to the UK government and Parliament on March 19.

The report was developed by academics at King's College, London. It is to be presented at the UK Parliament by the two organisations,

Parliament by the two organisations, Ibironke Adeagbo Foundation (IA-Foundation) and the International Organisation for Peace Building and Social Justice (PSJ), UK.

The Chief Executive Officer of IA-Foundation, Mrs Ibironke Adeagbo, told newsmen in a telephone interview on Saturday in Abuja, that the report was meant to keep the UK Government abreast of the current security crisis in Nigeria.

She said that the report had detailed and analysed "the nexus

between education and insecurity in Nigeria."

Nigeria, Africa's most populous nation and a former British colony has been at the receiving end of relentless abductions of school children, mainly in northern Nigeria.

On March 8, some 287 school children were kidnapped in a school in North western Kaduna State and 15 more were abducted in Sokoto State days later.

The recurring abductions, which started since 2014, have forced about 20.2 million children out of classrooms, disrupted homes and forced millions out of their farms.

Adeagbo said that the report entitled "Illiteracy and Insecurity-an Unholy Marriage", highlighted and appraised the relationship between education and insecurity across Nigeria's 36 states and the FCT.

"Education has been a key sector hit both directly and indirectly with direct attacks on learning institutions and student populations with kidnappings, killings, destruction of infrastructure and sowing of fear."

She said that the report would also be presented to Nigerian envoys and diplomats in the UK, to make them to have better grasp of the security issues at home.

Adeagbo, who has been at the forefront of tackling Nigeria's outof-school children crisis, said that the report was being presented at a time Nigeria and the UK had renewed their Security and Defence Partnership Pact.

According to her, the pact seeks to address and eliminate all forms of terror and insecurity in Nigeria for the long-term benefit of the West African country and its former colonial master.

She said that the report presentation was also coming at a time when the Federal Government showed resolve to tackle the problems with the appointment of retired Gen. Ja'afar Isa as the Executive Director of the Almajiri and Out-of-School Children Commission.

Adeagbo said that government was beginning to act on the recommendations made by the foundation on how best to tackle the out-of-school children crisis.

On his part, the Chief Executive Officer of PSJ UK, Mr Ayo Adedoyin, said that the report also looked at the causes, trends and implications of the high rate of insecurity on the development of education at all levels in Nigeria.

According to him, the absence of peace has been a national tragedy and, particularly so in the Northern and Middle belt parts of Nigeria.

He said that the development had caused severe disruptions in various sectors of the Nigerian economy, including agriculture and transportation.

Nigeria's Galloping Inflation Hits 31.70% In February – NBS

Nigeria's galloping inflation has dramatically increased to 31.70 percent in February from 29.90 percent in January 2024, National Bureau of Statistics report revealed.

This amount represents a 1.80 percent increase, according to the National Bureau of Statistics' latest CPI (Consumer Price Index) and inflation data, which was released on Friday.

This implies that the average price level increased at a faster rate in February 2024 than it did in January 2024.

The report read, "In February 2024, the headline inflation rate increased to 31.70 per cent relative to the January 2024 headline inflation rate which was 29.90 per cent."

Comparatively, on an annual basis, February 2024's inflation rate was 9.79 per cent higher than the 21.91 per cent recorded in February 2023.

Also, the month-on-month headline inflation rate in February 2024 reached 3.12%, an increase of 0.48% from January 2024's rate of 2.64%.

This indicates that the pace at which average prices rose in February 2024 exceeded the rate of price increase in January 2024.

The NBS further stated, "Looking at the movement, the February 2024 headline inflation rate showed an increase of 1.80 percent points when compared to the January 2024 headline inflation rate. On a year-on-year basis, the headline inflation rate was 9.79 percent points higher compared to the rate recorded in February 2023, which was 21.91 percent.

"This shows that the headline inflation rate (year-on-year basis) increased in the month of February 2024 when compared to the same month in the preceding year (i.e., February 2023).

"Furthermore, on a month-onmonth basis, the headline inflation rate in February 2024 was 3.12 percent, which was 0.48 percent higher than the rate recorded in January 2024 (2.64 percent)."

The latest inflationary surge is despite tightened monetary policy by the Central Bank.

At the latest Monetary Policy Meeting, the apex bank increased the benchmark interest rate by 400 basis points to a record 22.75 per cent.

Justifying reasons for the hike, the CBN Governor, Olayemi Cardoso, explained that members considered various scenarios including whether to hold or hike policy and concluded that inflation could become more persistent in the medium term and pose more regulatory issues if not well-anchored.

Social Cohesion: FG Launches SD3R Project In North East

The Federal Government of Nigeria (FGN) through the ■ National Counter Terrorism Centre (NCTC), Office of the National Security Adviser (ONSA). in collaboration with the European Union (EU) and a consortium of United Nations agencies, has launched a fresh initiative titled, EU Support for Disengagement, Reintegration Review. and Reconciliation Persons Formerly Associated with the Non-State Armed Groups (SD₃R of NSAGs) in North East Nigeria.

The joint initiative is to foster social cohesion, reduce stigmatisation, promote tolerance, and create space for acceptance as well as belonging within targeted communities in Adamawa, Borno, and Yobe States, according to a statement issued Thursday by the head, Strategic Communication, NCTC, ONSA,

Abu Michael.

While launching the Initiative, the National Security Adviser (NSA) Mallam Nuhu Ribadu, noted that the SD3R Project was conceived to promote peace and stability in the Northeastern part of Nigeria through community-driven reintegration and reconciliation process for persons formally associated with NSAGs.

He said, "The project also strives to support authorities in effectively investigating and prosecuting individuals accused of terrorism offences in the north east, ensuring meaningful accountability and redress for serious crimes."

The NSA added that ONSA through the NCTC would continue to coordinate the project in line with the Terrorism Prevention and Prohibition Act, 2022, Policy Framework and National Action Plan for Preventing and Countering Violent Extremism (PF-NAP for PCVE), 2017, as well as other relevant policy

documents.

In her remarks, the EU Head of Delegation to Nigeria and ECOWAS, Ambassador, Samuela Isopi, said healing and reconciliation can be achieved in the sub-region if all work together, leveraging on collective expertise.

"This is why we are happy to continue supporting this process in the hope that it will help rebuild broken bridges within families and communities," she added.

She noted that the Project was part of the broader EU support to the Lake Chad region which amounts to €2.5 Billion since 2014, stressing that its implementation would leverage on the expertise and experience of the four UN agencies involved: International Organisation for Migration (IOM) which is the lead agency, the United Nations Development Programme (UNDP), the United Nations Children's Fund (UNICEF) and the United Nations Office on Drugs and Crime (UNODC) which have

been working in the northeast of Nigeria for several years.

Dignitaries at the ceremony include: Governor of Borno State, Prof. Babagana Zulum, and his Adamawa State Counterpart, Ahmadu Umaru Fintiri who was represented by the Hon. Commissioner for Reconstruction, Rehab, Reintegration and Humanitarian Services, while the Yobe State Governor, Mai Mala Buni was represented by the Executive Secretary, Yobe State Emergency Management Agency, Dr Goje Mohammed.

Others include Ambassadors of the EU countries in Nigeria, as well as the UN Nigeria Resident Coordinator, Mr Mohamed M. Malick Fall; representatives of the UN agencies consortium, implementing the project.

There were also representatives of Federal and State Ministries, Departments and Agencies (MDAs), as well as Civil Society Organisations (CSOs).

Child Poverty:

Another Time Bomb In The Making?

urrently, millions of Nigerian children are going through wave of deprivations as a result of many factors including conflicts, the incursion of COVID-19 pandemic, government policies, inflation and other life threatening events resulting in the depletion of the incomes vis a vis purchasing power of many families.

Investigation by this paper has revealed that currently, children (persons between 0 - 17 age bracket) constitute half of Nigeria's over 200 million population. Therefore, fiddling with the future of this important demographic group is archetypal to the immolation of Nigeria's future.

A report on Multiple Overlapping Deprivations Analysis (MODA) published by the Federal Government of Nigeria, (FGN) in 2021 shows a staggering and disturbing incidents of child poverty in the country which called for concerted efforts by all stakeholders before the scourge consumes the nation.

Child poverty which is classified into two broad categories, monetary poverty and multi-dimensional poverty are real threats to the future of Nigeria considering the debilitating consequences an underdeveloped and energetic youthful population constitute to the nation.

An expert in criminology and conflict studies Dr. Baba Maishanu in a phone chat with our correspondent captured the debilitating portents of having high incidents of multiple deprivations in children such as the one we have currently in Nigeria as a time bomb.

"It is high time the federal government and all stakeholders rise to the occasion by ensuring that the incidents of child poverty is drastically reduced to the barest minimum, otherwise, in the nearest foreseeable future, these untamed youths will unleash their full wrath on the nation," he said.

Another expert and Social Policy Specialist, Dr. Yusuf Auta while speaking on the subject said non monetary poverty in children involved deprivations of the children's rights while multi-dimensional poverty in children means deprivations of children in at least three out

of the eight basic needs of the children.

These basic needs according to Auta include deprivations in water, sanitation, housing, information, nutrition, education and healthcare noting that any child who suffers deprivations in at least three of the areas at the same time is going through multi-dimensional poverty.

The MODA report also indicated that no fewer than 53.9 percent of Nigerian children are multi-dimensionally poor.

While dissecting child poverty by its dimension, the report indicated that deprivations in the nutrition sector amongst children aged between 0 - 4 is 33 percent adding that nine out of 10 children 95.2 percent of children under five years of age are not exclusively breastfed just as 83.9 percent of children between 6 - 23 months do not have recommended meal frequency and diversity standards. It also stated that three out of four children under four years suffer deprivations in healthcare dimension.

While enumerating the deprivations in education, the report states that 45. 4 percent of children aged 5 - 11 and 61.7 percent of children between 12 - 17 years suffer deprivations in

Why We Were Suspended, Hounded Out Of Zamfara Assembly – Lawmakers

The eight lawmakers suspended indefinitely by Zamfara House of Assembly, said they have been hounded out of the state by political thugs for exposing the worsening security challenges in the state.

The lawmakers also claimed that some security agents have been sent to hunt for them without any reason, a situation which made them to go into hiding.

Bashir Aliyu, who spoke on behalf of the eight suspended lawmakers at a news conference in Zaria on Sunday, said they would not be silenced until action is taken to tame the high level of insecurity in Zamfara.

Aliyu said when they moved to effect changes in the leadership of the assembly, it was to draw attention to the alleged prolonged absence of the Speaker and his deputy from the state.

He however said some forces in the state have since been hounding them instead of working to make the state safe.

According to him, some of the suspended lawmakers were attacked by thugs linked to a politician in the state during the wedding of the Deputy Governor's daughter on Feb. 24. He said a letter with reference no. ZMHA/ADM/223/Vol. 1, dated March 7, 2024, has now directed them to return the official vehicles in their care to the Clerk of the state Assembly within seven days.

"We want to notify Nigerians that democracy is in danger in Zamfara despite the prevailing insecurity, poverty and other challenges bedeviling the people of the state.

"We hence call for the intervention of key stakeholders to salvage the situation," Aliyu who represents Gumi I constituency added.

The News Agency of Nigeria

recalls that on Feb. 27, the eight lawmakers were suspended by the state assembly for allegedly holding an illegal plenary.

The suspension of the eight members was to give room for full investigation.

The suspended lawmakers are Bashir Aliyu (PDP-Gummi 1); Amiru Keta (PDP-Tsafe West); Nasiru Abdullahi (PDP-Maru South); Bashir Masama (PDP-Bukkuyum North); Faruku Dosara (APC-Maradun 1); Ibrahim Tukur (APC-Bakura Constituency); Shamsudeen Hassan (APC Talata-Mafara North) and Bashiru Sarkin-Zango (PDP-Bungudu West).

Budget Padding Allegation: ACF Carpets Senate Over Sen. Ningi's Suspension

Forum (ACF) has faulted the Senate for suspending the Senator representing Bauchi Central Senatorial District, Senator Abdul Ningi over his allegation of budget padding, with a call on the senate to act with more circumspection and sensitivity in processing criticism of its operations.

The forum expressed support for the suspended senator over his allegation of budget padding and claim that the 2024 budget is unfavourable to the North.

The Bauchi senator was suspended from the Senate for three months following his allegation that the 2024 budget is padded with N3.7 trillion not attached to any specific project, while claiming that the budget was skewed against the North with several Northern communities not benefitting from the projects and programmes in the budget.

Reacting to the development in a statement through its national publicity secretary, Professor Tukur Muhammad-Baba, ACF said the Senate was too hasty to have arrived at suspending Ningi and therefore urged the National Assembly to carry out a thorough investigation of such allegations in


While the forum noted that Senator Ningi's allegation has since been denied by the Senate as lacking in veracity, it however lamented that the interests of many Northern communities are at stake.

According to ACF, the process of suspending Ningi appeared nimbly rushed, with concerns looking more on the messenger rather than his message.

"ACF acknowledges the 10th Senate's constitutional privilege to determine how it operates or conduct its affairs. However, ACF expects that exercise of the privilege will always be hinged, strictly and transparently on relevant provisions in the Constitution relating to the principles of due process and fair hearing. This is critical for a body empowered to make laws for the country and to exercise oversight functions over the operations of the executive arm of Government.

"ACF notes that the whole saga hinged on the rather weighty allegation by Senator Ningi, euphemistically called "budget padding". Senator Ningi, and we must say others, had alleged that as much as the sum of N3.7 trillion is not rather egregiously attached to any specific project as it ought to, under the 2024 Budget of the Federation passed for implementation.

"ACF notes that the allegation has since been denied by the 10th Senate as lacking in veracity. However, the interests of many communities in Northern Nigeria are at stake. Rather than the route of a rushed suspension of Senator Ningi, ACF prefers a thorough investigation of the allegation by some statutory or ad hoc committees of the Senate. As things stand, in the eyes of the general public, the allegation of padding as well as those related to the inclusion of curious items that benefit specific communities of some Senators as "constituency

Ned Nwoko Discloses Receipt Of N1bn Constituency Projects Allocation

Nwoko, senator representing Delta north, says he was able to attract N1 billion worth of projects for his constituents.

Nwoko said this when he appeared on 'Mic On podcast', a programme hosted by Seun Okinbaloye, a journalist with Channels Television.

There has been renewed interest in allocations for constituency projects for federal lawmakers, after Jarigbe Jarigbe, senator representing Cross River north, claimed recently that some "senior" senators got N500 million for projects.

Jarigbe made the claim when

the senate deliberated on the allegation by Abdul Ningi, now suspended senator representing Bauchi central, who claimed that the 2024 budget was padded by N3.7 trillion.

Nwoko said he would have preferred a scenario where the constituency project allocation to every senator is fixed.

"The way it is done now, you basically rely on your weights and contacts to see what you can get for your people," he said.

"Well, it is just the system. Just the system. It is a system in Nigeria... like I said, I'd have preferred a situation where we all know what we are getting — you don't need to lobby for it and it is a standard thing.

"All the 109 senators from the onset should know what is going on in their particular district.

"A better approach would have been for senatorial uniformity. So if they say that everyone should get about N1 billion, so be it. But this way, you rely on your weight and contacts to see what you can get for your people.

"This is not money for us. It is money for projects within our senatorial districts. So if you have roads, water projects, programmes aggregate to a certain sum."

Asked if he received as much as N1 billion in allocation, the senator said: "Of course I did. That's why I am who I am. But these are projects for my people."

The senator said he does not want to know who the contractors executing the projects are, but only cares about the delivery of the projects he has been able to attract to Delta north.

On March 13, Ali Ndume, chief whip of the senate, said presiding and principal officers received more in constituency project allocation because "some animals are more equal than others".

They must set aside any political differences and work collaboratively with the security agencies and the Northern Governors Forum to find lasting solutions to the insecurity plaguing our region.

"We warn against the

politicization of security matters, as this only serves to worsen the already dire situation. It is imperative that all stakeholders come together in a spirit of unity and cooperation to tackle the root causes of insecurity and restore peace and stability in our communities.

"The KYV stands ready to support all efforts aimed at safeguarding the lives and properties of our people and creating a conducive environment for socioeconomic development in the North-West region. We call on Governor Lawal and Governor Raddah to demonstrate strong leadership and commit to working towards a peaceful and secure future for all residents of Zamfara and Katsina states, the statement said.

Fresh Abductions Of Schoolchildren And Nigeria's Descent To State Of Anomie

espite all the efforts federal government said it was making to ensure a watertight security across the length and breadth of Nigeria, criminal and rogue elements are seemingly riding our country roughshod and unleashing mayhem on families and communities in an unprecedented manner.

These outlaws from all indications seem to be on top of their games subjecting Nigerians to all sorts of abuses and infringing their fundamental rights in a manner which shows that they are really above the law. The government's ability to discharge its fundamental function of securing the citizens is being questioned everyday while the confidence of Nigerians on the government is ticking away by the minute.

These criminal elements have become so daring that in recent times, they carry out their dastardly acts unchallenged in the day time while security operatives who ought to checkmate them continue to slumber.

It is noteworthy to state that these heightened attacks on innocent Nigerians especially schoolchildren is coming not long after Nigeria's National Security Adviser (NSA) Malam Nuhu Ribadu stated in unequivocal terms that the administration of Ahmed Tinubu has succeeded in nixing the activities of those rogue elements.

While pushing home his points, the NSA noted that Abuja-Kaduna highway which earned notoriety as the flashpoint and den of kidnappers has been rescued and kidnapping or any untoward activity has eluded the highway for many months.

Ribadu also told Nigerians that the country is also capitalizing in the renewed peace in Niger Delta ushered by the administration to boost its daily oil production output hence swelling the national revenue and the GDP.

But from recent events and degenerating insecurity, it is important to tell the government that all is not well and the picture it is trying to paint is suspicious.

The resurgence of Schoolchildren abductions and the concomitant national odium and embarrassment can not be wished away with the wave of the hand.

It has also shown that the government is either living in denial, ignorance or

both. Whatever it is, Nigerians are really Iiving in perilous times which necessitated government's quick action if its capacity or the political will is intact. It is a misnomer that children who ought to be enjoying the perks and joys of childhood are currently going through their worst times in the history of Nigeria. At no time in history even during the civil war had children came under such heavy stress and attacks.

It is really heartbreaking that in one fell swoop, criminal elements in separate attacks abducted no fewer than 300 school children across northern states.

The gory spectacle started when hundreds of armed men stormed LEA Primary and Secondary School Kuriga, Kaduna State in broad day light and abducted 287 schoolchildren without any challenge. Less than forty eight hours later, another daredevil men armed to the teeth, stormed an Almajiri school in Sokoto State and seized about 15 schoolchildren.

All these are happening despite the claims of the government of expending trillions of naira to fight insecurity.

For instance, the government through the Nigeria Bureau of Statistics (NBS) disclosed that the princely sum of N5 trillion has been expended to procure tanks, armoured fighting vehicles and other military hardwares majorly from Singapore in the last quarter of 2023.

It is the informed stance of this paper that the security situation in the country May be the result of the serious corruption and vast pecuniary interest embedded by conflict entrepreneurs, otherwise, there would have been no plausible explanation to such a huge expenditure in the face of the intractable social insecurity which the country is grappling with at the moment.

If such a whopping amount is expended in eradicating child poverty and extending social safety nets to the over 133 Nigerians ensnared in multi-dimensional poverty, Nigeria's present and future generations would have been saved. It is our view that government should stop its procrastination and fiddling while outlaws are on the verge of taking over the land. A stitch in time saves nine

Ajaokuta: CSO Tackles Former Kogi Deputy Governor, Labels TV Appearance Shameful

'n the ongoing discourse surrounding the state of the Ajaokuta Steel Company, a Civil Society Organization (CSO), Integrity Watch, has entered the fray, taking aim at the former deputy governor of Kogi State, Hon. Simon Achuba, and his recent assertions regarding the management of the steel industry.

In a statement issued by Integrity Watch's Director General, Prince Daniel Maman Musa, the organization expressed disdain over Achuba's appearance on Arise TV, labeling it as "shameful" and questioning his moral standing to accuse former Governor Yahaya Bello of hindering Ajaokuta's development.

Achuba, in his interview, accused Bello of thwarting efforts to revive Ajaokuta Steel, alleging personal interests in the company's operations. He cited instances of bureaucratic interference and alleged mismanagement under Bello's administration, fueling the controversy surrounding the steel industry's stagnation.

The Senate's recent formation of a 10-member ad hoc committee to investigate Ajaokuta's decline further underscores the gravity of the situation. Senator Natasha Akpoti-Uduaghan's motion, identifying political will and bureaucratic corruption as contributing factors, aligns with Achuba's claims, adding weight to the calls for transparency and accountability.

However, Integrity Watch rebukes Achuba's accusations against Bello, asserting that the Ajaokuta Steel issue transcends the state government's jurisdiction. They highlight historical setbacks dating back to 1983 when Muhammadu Buhari halted the project, emphasizing its exclusive federal mandate. How can Governor Bello, who became Governor of Kogi State on January 27, 2016, be responsible for the Ajaokuta crisis dating back to 1983, when Bello was barely 7 years old? The host of the Arise TV program, Dr. Abati, exposed Achuba's flaws by asking questions on how he could ridiculously accuse Bello of the challenges surrounding Ajaokuta steel development.

Moreover, Integrity Watch challenges Achuba's credibility, citing a purported history of corruption and misconduct during his tenure in various positions. They allege Achuba's dismissal from previous roles, including his service as former Deputy Speaker with the state assembly and as Director-General in the Ministry of Environment under former Governor Idris Wada's administration. He was said to be found diverting government funds by issuing his personal receipt to collect funds belonging to the Kogi State Government and sacked for gross misconduct and embezzlement, as well as his time as deputy governor where he was also sacked for abuse of office, fraud, and gross incompetence.

portrays Achuba as an unreliable figure, prone to political opportunism evidenced by his frequent party affiliations. They argue that such instability undermines his moral authority to implicate Bello in corruption allegations.

Contrary to Achuba's claims, Integrity Watch defends Bello's administration, transparency its accountability in managing state funds.

In a scathing critique, Integrity Watch They cite numerous awards received by Bello for good governance and excellent service delivery, challenging Achuba's narrative of malfeasance within the government.

Osun PDP Accuses Oyetola Of Using Tinubu's Name To Endanger Peace, Governance

The Osun State chapter of the Peoples Democratic Party (PDP) has warned former Governor Gboyega Oyetola to stop using and dropping the names of President Bola Tinubu to disrupt governance in Osun state, warning that the state will open a can of worms on the former governor unless he stopped his disruptive activities.

In a strongly worded statement issued by the party's chairperson in the state. Sunday Bisi, on Sunday, the party accused the former governor of being a bad loser who has continued to pursue a failed agenda to make Osun state ungovernable through the dropping of Mr President's

The statement reads further: "We are constrained to bring to the attention of Mr President and the entire Presidency the untowards activities of former Governor Oyetola which are capable of destroying the peace and stability of Osun state and negatively undermine the presidential agenda for Osun state, South West and Nigeria as a whole.

'We start by noting that the opposition has a legitimate right to play the role of the opposition. Such opposition roles do not however entail evil moves targeting at destroying the peace of the state, misrepresentation of presidential

intention, the deliberate disruption of state-federal relations or attempted unlawful abuse of federal power against state officials performing their statutory roles. That will amount to malignant behaviour and a direct threat to democratic ideals.

We posit that Mr Oyetola was not the first person to lose an election. Great democrats abide by people's wishes and prepare to recontest. They dont pull down the house; they don't get consumed under vengeful poison.

'Governor Adeleke, despite being rigged out in 2018, congratulated Mr Oyetola and moved abroad to complete his education. He instructed us never to attack the new government but to go and prepare for 2022, a process we launched when the timetable for the election was released.

"In 2022, Osun people voted for Governor Adeleke. Right now, the governor is delivering many projects and programmes which Oyetola failed to achieve under four years. This government has full records of several projects for which money was collected without the jobs being done. Mr Governor abandoned the idea of a probe and is instead completing many projects and starting new ones. Osun is today one of the most peaceful states in Nigeria attracting multiple interests and

attention of foreign investors

"Surprisingly , Mr Oyetola has been dropping Mr President's name to manipulate federal agencies to serve his selfish interest. The other time, he hijacked SMEDAN SME programme to serve his own faction of APC, even leaving out other APC members, giving Mr President a bad name. He did the same on rice distribution which he allegedly took from NEMA but which he shared to his faction against reaching out to the generality of Osun people as Mr President clearly preferred in line with the law.

"Rather than working to unite his party ahead of 2026, he is busy trying to make the state ungovernable, disrupting federal – state collaboration and attempting to use federal agencies such as the FCT DSS to harass state officials. We learnt Oyetola has used the FCT DSS to threaten arrest of the spokesperson to the Osun State Governor for performing his statutory duties of projecting and promoting Mr Governor.

"We warn that such an attempt at arm twisting is a failed strategy as officials and citizens are entitled to the enforcement of their fundamental human rights as enshrined in the constitution and as the same constitution also regulates human rights and intergovernmental relations among the three tiers of government.

We are also convinced that both the Presidency and the national headquarters of the DSS will not endorse deployment of sensitive state services to pursue personal political vendetta.

"Mr Oyetola should stop his evil agenda against Osun state because he should know we have the capacity to tame him but for the state government's due respect for Mr President. If he does not stop, we will open his records which we are not doing because of our respect for the Presidency.

"We urge Mr President and the entire Presidency to nip in the bud the nefarious, vindictive, anti-state and vengeful activities of Mr Oyetola which are tarnishing the image of the Number One Citizen of the nation as he is using the President's name to pursue vendetta and activities directly contrary to the bigger agenda of the Presidency.

"Mr President should call Mr Oyetola to order before plunging Osun into an avoidable crisis. Osun is peaceful and our Governor is delivering dividends of democracy under the umbrella of good governance. Kogi Govt Slams EFCC Over 'Baseless Witch-hunt' Of Yahaya Bello

The Kogi State government has called out the Economic and Financial Crimes Commission (EFCC) over what it described as a "witch hunt" of the immediate past governor, Yahaya Bello.

A statement by the Commissioner for Information in Kogi State, Kingsley Fanwo on Friday, claimed that the witch-hunt was orchestrated by some political actors around the Presidency bent on destroying the image of the former governor.

It said the world would be eager to know why the Commission was trying so hard to find what was not missing, insisting that its funds were not missing, and called on the EFCC to desist from mentioning the name of Kogi State in its ongoing persecution.

"We believe that this ignoble agenda is unknown to President Bola Tinubu, who trusted those people with power with the hope that they will use it judiciously for the greatness of our nation.

"Unfortunately, they have decided to use the privileges given to them as tools for political vendetta.

"The amended charges in which the name of the former governor, Bello, was mentioned are false, frivolous, fictitious, and far from the truth. They are cooked-up charges that signpost their desperation to call a dog a bad name to hang it.

"The intention was to sensationalise the whole scenario and promote a media war against the former governor and other officials of government.

"We have seen how low EFCC and its paymasters can go to pander to the political agenda of those afraid of the rising profile of Alhaji Yahaya Bello," it added.

The state government called on President Bola Tinubu to order a special probe into "what is happening in Kogi State before the EFCC is pushed into being used as a hired gun by political hawks who are acting a selfish and overambitious script."

It said those who had personal grievances could vent their grievances without dragging the name of Kogi State in the mud.

The commissioner maintained that the Kogi government "believes in transparency, accountability, and probity in line with the trend from 2016".

Furthermore, the statement read in part, "As a subnational in the Nigerian nationhood, we wish to express our utmost respect for agencies set up to perform specific functions towards the greatness of Nigeria.

Christopher Kolade: Politicians In First Republic Worked For Nigeria — Today, They Are selfish

hristopher Kolade, former Nigerian high commissioner to the United Kingdom, says the current crop of Nigerian politicians prioritise their personal interests over the nation's.

Kolade, who spoke in an interview with Channels Television's Amazing Africans, said he never joined politics because he "would not be able to be myself".

The nonagenarian said things have changed compared to the politicians of the first republic who "actually were serving the country", and were imprisoned because of their beliefs.

Nigeria's first republic lasted from 1963 to 1966.

"My view of politics is that the practice of politics can be very sensitive and one can begin to do things, begin to participate in decisions that conflict with the values, the standards, the principles that one believes. That has been my experience," he said.

"I've never gone into politics because the way it was being practised, I thought I would not be able to be myself if I became a politician now.

"That may be simply my own weakness but this is the situation and so when I see politicians today and the way they behave, if I compare today's politicians with politicians of the First Republic, for example.

"I can tell that my experience of the politicians of the First Republic was that they actually worked for Nigeria; they actually were serving the country, they put themselves and their own interests lower than the national interests and some of them in order to serve the country well were actually imprisoned, they suffered hardships in order to get the country to where they thought it should go.

"I think that has changed. I believe that today many politicians, in fact most politicians that I know of, tend to put their own interests ahead of the national interest."

Kolade, who was appointed chair of the Subsidy Reinvestment and Empowerment Programme (SURE-P) by the Goodluck Jonathan administration in 2012, said his friends advised him against

accepting the role to safeguard his reputation.

He said despite the advice to decline the offer, he went on to accept the job because "somebody must do it".

"In fact, there was a group of young people that I was mentoring at the time and they said to me in a meeting: 'We respect you too much, don't go for this'," he added.

"I asked for God's direction, I asked them a question: 'I said so if I don't take it, if I say because I want to protect my reputation I don't take it, whom shall I point to and say you take it, you go and endanger your reputation, you go and do this?' I said so I cannot refuse to take it because I know somebody must do it.

"What I can do is to say if I

go and do it, God is able to see me through it. That was what happened.

"So, friends can tell me their preference and sometimes I even have my own preference but I remember always that I'm God's child and that he has my best interests at heart."

Kolade later resigned from the role in 2013, citing advanced age, corruption and transparency

Alleged N84bn Fraud: Declare Yahaya Bello Wanted Now, Okai Urges EFCC

Representatives candidate for Dekina/Bassa in the 2023 elections, Usman Okai Austin, has called on the Economic and Financial Crimes Commission (EFCC) to declare Former Kogi State Governor, Alhaji Yahaya Bello wanted over the Misappropriation of funds.

Okai also issued a fervent call to safeguard the interests of the people of Kogi State regarding the misappropriation of funds by the former governor, Yahaya Bello.

According to him, despite the arduous task of protecting the state, it is imperative not to overlook the plight of civil servants grappling with the repercussions of fiscal misdeeds.

Recall that on August 31, 2021, Justice Tijani Garba Ringim, a vacation judge, had ordered the freezing of the account following an exparte application filed by the Economic and Financial Crimes Commission (EFCC).

The anti-graft agency, in a 13-paragraph affidavit in support of the ex-parte application, had stated that it received credible and direct intelligence, which led to the tracing of funds reasonably suspected to be proceeds of unlawful activities in an account No. 0073572696 domiciled in Sterling Bank Plc with the name Kogi State Salary Bailout Account.

Moving the application for the interim forfeiture of the funds on August 31, 2021, A. O. Mohammed, counsel to the EFCC, had urged the court to grant the order to prevent $\bullet Urges\ Kogites\ to\ support\ EFCC's\ efforts\ to\ bring\ Bello\ to\ justice$

further dissipation of the funds in the account.

Mohammed had also told Justice Ringim that the N20 billion meant to augment payment of salary and running cost of the government was kept in an interest-yielding account with the bank.

According to him, "Instead of using the money for the purpose it was meant for, Sterling Bank Plc, acting on the instruction of the Kogi State government, transferred it from the loan account and placed it in a fixed deposit account."

Reacting, Mr Kingsley Fanwo, Kogi State Commissioner for Information debunked the allegation, stating that the State government judiciously used the funds for its intended purpose.

While countering Fanwo's comment, Okai said, "It is untenable to shield any individual, including former Governor Yahaya Bello, at the expense of the welfare of Kogi workers. The ramifications of such actions are profound, with millions of lives hanging in the balance."

Recently, the Economic and Financial Crimes Commission (EFCC) named former Kogi State Governor Yahaya Bello in an ongoing corruption case but has yet to formally charge him.

Mr Bello's nephew, Ali Bello, and his associate, Dauda Suleiman, the two defendants in the case, were accused of diverting funds belonging to Kogi State.

But in the newly introduced count, the two defendants in the case were accused of conspiring with Mr Bello to convert the total sum of N80.2 billion (N80,246,470,089.88) belonging to Kogi State Government to personal use.

Reacting to the development via a statement made available to newsmen in Abuja on Saturday morning, Okai urged Kogites and all concerned Nigerians to galvanize support for the EFCC's efforts to bring him to justice.

He underscored the urgency for enhanced scrutiny of Bello's alleged transgressions.

"What is EFCC waiting for to declare Bello wanted? And why does EFCC put 2015 in the charges, or are they trying to give ex-Governor a soft landing to escape judgment?" Okai questions EFCC's integrity.

"The staggering loss of billions of naira, a burden borne by the citizens, serves as a stark reminder of the imperative to uphold accountability and transparency in governance.

"Moreover, revelations of property acquisitions in lucrative locales like Dubai, Maitama, and Lagos raise serious questions about fiduciary responsibility.

"It is disconcerting that despite the confiscation of numerous properties by the Economic and Financial Crimes Commission (EFCC), investigations were impeded by immunity provisions.

Now, with Bello out of office, I urge Kogites and all concerned Nigerians to galvanize support for the EFCC's efforts to bring him to justice. The misappropriation of public funds cannot be tolerated, and those responsible must be held accountable irrespective of their



former positions."

Speaking further, Okai said, "This call to action is not driven by personal animus but rather by a steadfast commitment to the principles of good governance and fiscal probity.

The good governance advocacy implores citizens to set aside differences and unite in the pursuit of justice and accountability.

"As the wheels of justice turn, it is incumbent upon every citizen to remain vigilant and resolute in demanding transparency and accountability from those entrusted with the stewardship of public resources.

"The future well-being of Kogi State hinges upon the integrity of its leaders and the diligence of its citizens in upholding the rule of law.

Meanwhile, Okai reiterated the imperative of collective action in safeguarding the interests of the people. Let us stand together in the pursuit of justice, ensuring that the misappropriation of state funds does not go unchecked. The time for vigilance is now."

he Socio-Economic Rights and Accountability Project has urged the Senate President, Godswill Akpabio, to recall Senator Abdul Ningi who was suspended for three months over his allegation of budget padding.

Ningi, the lawmaker representing Bauchi Central, was suspended for three months over an interview in which he alleged that the National Assembly padded the 2024 N28.7 trillion budget as against N25tn.

He was quoted as saying, "For the first time in Nigerian history,

budgets. One budget was approved by the National Assembly and signed by President Bola Tinubu, and the one was implemented by the presidency.

Two days after his resignation as the Chairman of the Northern Senators' Forum, Ningi was replaced by Senator Abdulaziz Yar'Adua (APC Katsina Central).

In a statement dated March 16, 2024, and made available to journalists on Sunday, March 17; and Kolawole Oluwadare, the group urged Akpabio "to immediately reinstate whistleblower Abdul Ningi who was recently suspended from the Senate over his allegations that the lawmakers padded the 2024 budget by irregularly inserting projects worth N3.7 trillion.

SERAP equally told the Senate President to refer the allegation to the country's anti-graft agencies the Economic and Financial Crimes Commission, and the Independent Corrupt Practices and Other Related Crimes Commission, which would improve public trust in the Senate.



Outrage As FG Signs Rail MoU With 'Unknown' UK Firm

Nigerians expressed displeasure over the signing of a memorandum of understanding (MoU) between the ministry of transportation and MPH Rail Development Limited.

The company, registered in the UK, is expected to manage design, construction, commissioning, operation, and eventual transfer of the Port Harcourt-Enugu-Calabar-Abuja standard gauge rail line.

Minister Transportation, Sen. Said Alkali on behalf of @NigeriaGov has signed an MoU with Messrs MPH Rail Development (UK) Limited

have for the design, construction, operation & transfer of the Port Harcourt-Enugu -Calabar-Abuja SGR Line on a PPP basis," the ministry wrote on its X page.

The ministry said the signing followed the approval of the outline business case and the issuance of a compliance certificate by the Infrastructure Concession and Regulatory Commission (ICRC).

This clearance, the ministry said, enables the firm to focus on compiling the necessary documentation for the federal executive council's approval to advance the project.

In another statement. ministry said documents required for the project's progression include a comprehensive feasibility study report, a complete business case study, an environmental and social impact assessment, the development of a resettlement action plan, and the formulation of a financial model to facilitate project implementation.

The ministry said this would ensure the transfer of the project to the government under a PPP arrangement without incurring loans or debts for the Nigerian government.

However, social media users have knocked the agency for signing an MoU with a company that was only incorporated less than five years ago - September 26, 2019.

Others have described it as a "PI&D (sic) saga in the making", adding that a project of such magnitude should not be entrusted to a young company of unknown history.

According to The Cable , the $% \left(1\right) =\left(1\right) \left(1\right) =\left(1\right) \left(1\right) \left($ company was formed by one Andrew James, a British citizen, in 2019 and went on without any relationship with the Nigerian government or private sector

untill August 24, 2023, when the company appointed Osinowo Rotimi as the first director with a Nigerian background.

Subsequently, Sayeed was also appointed as a director in January 2024.

Further checks that the company had filed as a dormant organisation three times since its registration in 2019.

Other discrepancies pointed out by disgruntled Nigerians are that the company, since its incorporation in 2019, has no track record of engaging in any rail construction business and lacks a website.

CBN Reiterates Directive To Banks On Utilisation Of Forex Gains

The Central Bank of Nigeria (CBN) has reaffirmed its directive to banks regarding the utilisation of foreign currency (FCY) revaluation gains.

In a circular released by the bank on Thursday and signed by the Acting Director of the Banking Supervision Department, Adetona Adedeji, the CBN advised banks against undertaking such actions.

In the circular, referencing a letter dated 11 September 2023, the CBN emphasised the need for banks to exercise utmost prudence in handling these gains.

According to the directive, banks are required to set aside FCY revaluation gains as a counter-cyclical buffer to mitigate any adverse movements in the foreign exchange (FX) rate. It specified that banks should not use such gains to pay dividends or cover operating expenses.

"Further to our letter dated September 11, 2023, referenced BSD/DIR/CON/LAB/16/020 on the above subject, the Central Bank of Nigeria wishes to reiterate that banks are required to exercise utmost prudence and set aside FCY revaluation gains as a counter-cyclical buffer to cushion any adverse movements in the FX rate.

"In this regard, banks shall not utilize such FX revaluation gains to pay dividends or meet operating expenses. Please be guided accordingly," it said.

'Banks and financial institutions are advised to take note of this directive and comply accordingly to avoid any sanctions or regulatory actions from the CBN."

In September 2023, the N instructed banks to cease using profits from their foreign exchange revaluation for dividends and operational costs. The directive, outlined in a letter dated 11 September 2023,

and signed by the then Director of the CBN's Banking Division Department, Haruna Mustafa, was to be implemented promptly.

"The bank thus approved the following prudential guidance and directives for immediate implementation by banks. Treatment of FX Revaluation Gains: Banks are required to exercise utmost prudence and set aside the FCY revaluation gains as a counter-cyclical buffer to cushion any future adverse movements in the FX rate. In this regard, banks shall not utilise such FX revaluation gains to pay dividends or meet operating

"Single Obligor Limit (SOL): Banks that inadvertently breach the Single Obligor Limit (SOL) due to the FX policy will be granted forbearance application to the CBN. The forbearance shall apply only to existing facilities as of the effective date of this policy. Such banks shall be exempted from the regulatory deductions on the excess above the SOL limit in their CAR computation.

"Net Open Position Limit: Banks that exceed the NOP prudential limits due to the FX revaluation shall be granted forbearance for the breach upon application," the circular stated.

Swift Networks, a facilities-based telecommunications company, says it is restoring capacity from some of its cable vendors.

On March 14, subsea cable providers were affected by major cuts to undersea submarine cables, disrupting internet traffic in major parts of Africa.

In Nigeria, banking and telecommunications services were significantly hampered.

Some of the affected submarine communications cables included the West Africa

Cable System (WACS), the Africa Coast to Europe (ACE), MainOne, and SAT3.

According to available records, Swift Networks is among seven internet service providers (ISPs) that have connected to the MainOne submarine cable system in Nigeria.

Giving updates on the undersea

cable cuts in a notice to customers on Saturday, the company said due to its efforts in restoring capacity, some of its customers may notice improvements in its broadband service.

The firm, however, said some customers may still have trouble accessing certain websites as the cable vendors are yet to reach full capacity.

"We have started to restore capacity from some of our cable vendors. As such, you may notice improvements in our broadband service," the company said.

"However, as our cable vendors are yet to reach full capacity, you may still experience intermittent broadband connectivity and/ or difficulty in accessing some websites."

Swift said it anticipates further improvements over the weekend as it continues "with all efforts to get to full capacity".

The organisation also urged customers to contact its customer care team for assistance or clarification.

CBN Speaks On Fertiliser Donated To Boost Food Production

The Central Bank of Nigeria (CBN) has provided clarifications regarding its recent donation of 2.15 million bags of fertilisers to farmers across the country through the Federal Ministry of Agriculture and Food Security.

The CBN had on Wednesday donated fertilisers valued at over N100 billion at current market prices, aiming to support domestic agricultural production and address rising food inflation.

Inflation in Nigeria has continued to rise largely because of the high cost of food items. As of February, the country's annual inflation rate rose to 31.70 per cent from 29.90 per cent in January.

In his remark, the Governor of the Central Bank of Nigeria, Olayemi Cardoso, said the bank is committed to price stability, recognizing the significant impact of food prices on inflation. Acknowledging persistent inflationary pressures, particularly in food prices, he emphasised collaboration with the agriculture ministry to address these challenges.

"This reinforces the critical need to address food inflation as a pivotal aspect of managing overall headline inflation rates. While the CBN has been implementing comprehensive measures to curb inflation, it is evident that in the short term, inflationary pressures may persist, predominantly driven by escalating food prices," Mr Cardoso said.

The apex bank governor had upon assuming office suspended all direct interventions in the real sector of the economy saying it was not the apex bank's mandate.

In a note published on its website on Saturday, the bank said it has not initiated any new intervention but has rather donated fertilisers from the remnants of its stock, which were blended under its previous interventions in the agricultural sector.

"These fertilizers are now being donated to farmers across the country through the Federal Ministry of Agriculture and Food Security. This decision is aimed at supporting domestic agricultural production rather than allowing the fertilizers to remain unused and go to waste. We anticipate that the fertilizers will ultimately support our overall objective of price stability which is being challenged by rising food inflation," it said.

On why the fertilisers were released to the ministry, the CBN said it is realigning its focus towards its core mandate of ensuring monetary and price stability, thus stopping its direct involvement in development finance interventions.

However, it said it will support relevant organisations that possess the expertise and capacity to intervene directly.

The bank said the partnership was aimed at supporting the ministry's efforts to enhance food productivity and security, ultimately curbing food inflation

and reinforcing the CBN's pursuit of price stability.

Addressing concerns about the distribution process, the CBN stated that it collaborated with the ministry due to its expertise and infrastructure for efficient delivery to farmers. It also clarified that they will be distributed to farmers free of charge to enhance agricultural productivity and ultimately contribute to price stability.

Giving details of the donated fertilisers, it said the 2.15 million bags contained various blends of fertilizers, with each bag of fertilizer weighing 50 kilograms.

A breakdown of the donated fertilisers includes 545,000 bags of NPK 20-10-10, 542,200 bags of NPK 27-13-13, 378,091 bags of NPK 15-15-15, 635,444 bags of UREA, and 50,000 bags of SSP.



Undersea Cable Cut: MainOne provides more info, says service restored to some customers

ainOne, a Digital Infrastructure Service Provider, on Saturday, said that it had restored service to some customers and was actively working on restoring all services through capacity acquired on available cable systems.

The organisation made this known via a statement on its website after it earlier said it would take two weeks to five weeks for it to fully restore internet services.

The statement said that the estimated repair time that it had earlier declared was for its submarine cable fault to be fixed.

"The repair time is to enable our services to become fully restored and independently supply capacity to customers.

"We have already restored services to some customers and

are actively working on restoring services to others via capacity acquired on available cable systems," the statement said.

Earlier, MainOne said that it recognised the impact of the outage and was working tirelessly to make available restoration of capacity for temporal relief where feasible.

"We are very optimistic that our cable will be repaired as planned and services fully restored so that we can continue to operate with continued integrity of the submarine cable," it said.

The News Agency of Nigeria (NAN) recalls that the Nigerian Communication Commission (NCC) had said that the internet disruptions being experienced by organisations, banks, and individuals were a result of damage affecting major undersea cables near Abidjan in

Côte d'Ivoire.

The NCC said that the damage was causing downtime across West and South African countries.

It said that the cuts occurred somewhere in Cote d'Ivoire and Senegal, with an attendant disruption in Portugal.

It said that cable companies

- West African Cable System
(WACS) and African Coast
to Europe (ACE) in the West
Coast route from Europe – had
experienced faults, while SAT3
and MainOne had downtime.

The regulatory body added that similar undersea cables providing traffic from Europe to the East Coast of Africa, like Seacom, Europe India Gateway (EIG), and Asia-Africa-Europe 1 (AAE1), were said to have been cut at some point around the Red Sea.

This, it said, resulted in the

degradation of services across these routes.

NAN reports further that in an earlier statement, MainOne had declared a force majeure on its contractual obligations while explaining steps to restore connectivity.

The force majeure is an unforeseeable circumstance that prevents someone from fulfilling a contract.

The unforeseen circumstances may be natural disasters (fire, storms, floods), governmental or societal actions (war, invasion, civil unrest, labour strikes), or infrastructure failures (transportation, energy).

Freed Opposition Leader Predicts South Sudan Closes Schools Win In Senegal Elections

Senegalese eading opposition figure Sonko Ousmane on Friday predicted a comfortable first-round win for his coalition's presidential candidate, in his first public appearance a day after being freed from

Sonko was greeted by hundreds of supporters outside a hotel in the capital Dakar, where he held a news conference with his deputy and presidential hopeful Bassirou Diomaye Faye, also released from prison late Thursday.

Sonko predicted a convincing first-round victory for Faye if the March 24 vote went ahead without fraud.

"If the election goes well, I don't think we'll get less than 60 percent," he

He called on "the Senegalese people to remain vigilant, especially as there are rumors of corruption circulating," while adding that he did not have "sufficient evidence" on the matter.

Disqualified from running in this vote, 49-year-old Sonko has been at the center of a more than two year stand-off with the state.

Sonko named Faye to replace him on the presidential ballot and in Friday's speech, he reiterated his backing for

"My person is not the most important thing. My objective is to help win the election," he said.

"I did not choose Diomaye by chance," he added, referring to Faye.

Sonko reserved his sharpest attacks

the presidential camp's candidate, former prime minister Amadou Ba.

But he insisted "the election will not be a war."

"There will be no revenge, there will be justice," Sonko said, referring to accountability for those currently in power should his camp win.

Fave is thought to be one of the favorites to win the presidential election.

His coalition had kicked off the campaign while he was still behind bars, pitching him as the candidate for "system change" and "left-wing pan-Africanism."

The opposition figure has promised to reclaim Senegal's sovereignty and renegotiate oil and gas contracts, as well as defence agreements if elected.

In the early hours of Friday, thousands thronged the streets of Dakar, singing and dancing as Sonko and Faye were driven away from the city's Cap Manuel prison.

Upon his release, 43-year-old Faye, smiling and raising his arms to the sky after almost a year behind bars, praised the "support and solidarity" of his followers.

Sonko Fave and benefited from an amnesty law passed by MPs last week.

It had been proposed by the outgoing president with the aim of easing tensions after three years of unrest, reignited last month by his last-minute postponement of the presidential vote.

The impromptu rally after the release of Sonko and Faye was the largest for any of the 19 candidates since campaigning began on March 9.

It was an indication of the popularity of both men, particularly Sonko, who is not even in the race for the top job. Their release is now likely to galvanise the election campaign.

Faye had been imprisoned since April 2023 charged with contempt of court, defamation and acts likely to compromise public peace after posting a message critical of the justice system.

His manifesto reflects the themes which have made Sonko popular, including attacks on corruption, elites, multinationals and former colonial ruler France.

The legal case against Sonko, along economic and social tensions and concerns about whether Sall would run for a third presidential term, led to deadly unrest between 2021 and 2023.

Sonko was jailed at the end of July on a string of charges, including provoking insurrection, conspiracy with terrorist groups and endangering state security.

His political party was also dissolved.

Earlier Friday, Senegal's Supreme Court confirmed the date of the delayed presidential election, rejecting an attempt by disqualified candidates to cancel the date.

The petitioners had presidential wanted decrees setting the date for the election and the duration of the campaign to be suspended.

But the court said the issue did not fall within its purview, adding that the Constitutional Council had "full jurisdiction in electoral matters."

outh Sudan Saturday said it would close schools and told children not to play outside temperatures were set to soar to an exceptional 45 degrees Celsius.

"There are already cases of death related to excessive heat being reported," the ministries added, without giving further details.

The government will close all schools from March 18 due to the "serious health hazards" posed to students.

"Parents are advised to



stop their children from playing outdoors," the statement added, saying young children should be monitored for signs of heatstroke.

Episodes of drought and increasingly extreme rainfall are adding to already difficult living conditions in South Sudan, which has been plagued by violence and economic instability since it declared independence from Sudan in 2011.

Scientists say recurring heatwaves are a clear marker of global warming and that they are set to become more frequent, longer, and more intense.

One of the poorest countries in the world despite large oil reserves, South Sudan has spent almost half of its life as a nation at war. The nation has also endured persistent natural disasters, famine, economic collapse, and communal conflict.

Guinea Sacks Electricity Chief After Protests

uinean authorities Saturday announced that the head of its national electricity company had been sacked after repeated power cuts sparked deadly protests in the militaryruled country.

Laye Sekou Camara of Electricity in Guinea, EDG was dismissed along with his two deputies, Fode Soumah and Abdoulaye Kone, in a decree signed by junta chief General Mamady Doumbouya.

The managing director and deputy of Guiena's national oil company were also dismissed in a between protesters and separate decree.

"Those responsible for this situation (linked to the power cuts) owe us an explanation and everyone must take their share of responsibility," Prime Minister Amadou Oury Bah told the press on Friday.

The decision comes after two children, aged eight and 14, were shot dead amid violent protests on Tuesday in Kindia,

130 kilometers east of Conakry.

Clashes also erupted security forces in Conakry on Thursday after a power cut plunged much of the capital into darkness.

In a statement, EDG said the blackout was the result of "an incident on a high-voltage pylon."

Guinea, which is poor despite considerable mineral and natural resources, has endured decades of dictatorial rule and suffers from fuel shortages and power cuts.

South Sudan President Fires Finance Minister Amid Economic Crisis

President Salva Kiir has fired the nation's finance minister without giving a reason, although the move comes amid worsening inflation and a sharp depreciation of the local currency against the dollar.

The dismissal finance minister, Bak Barnaba Chol, was announced in a decree read essential goods. on state TV late on Friday.

As South Sudan's economic crisis continues, some civil servants have gone at least six months being without salaries.

Over the past two months the local currency, Sudanese South pound, has lost about half of its value against the dollar, fueling a surge in prices of food and other

Miami Beat DC United Without Messi

uis Suarez came off the bench and scored twice as Inter Miami, without the injured Lionel Messi, won 3-1 at D.C. United in Major League Soccer on Saturday.

Suarez continued his prolific start to life in MLS with his sixth goal in seven games in all competitions for the South Florida club

Jared Stroud put for D.C. United ahead, latching onto a Mateusz Kilch pass and firing a first-time shot past Drake Callender.

The lead lasted only for 10 minutes, however, with Leonardo Campana leading the Miami attack in place of Suarez, seeing a header saved by Alex Bono but then, after D.C. failed to clear, turning in after the ball was scooped to him by Federico Redondo.

Busquets delivered a superb cross-field pass to set Robert Taylor in down the left but his low drive clipped the outside of the post on the stroke of half-time.

Uruguayan Suarez was brought on in the 62nd minute and the 37-year-old was to settle the contest.

Just 10 minutes after coming on Suarez finished off a fine move, turning in a low cross from Campana at the back post.

Then Diego Gomez, Miami's powerful Paraguayan midfielder, won the ball in the centre of the field and broke forward, finding Suarez, whose route to goal was initially blocked.

But Suarez was able to find space for a chip that Bono clawed at but was unable to stop crossing the line.

D.C United had Pedro Santos sent off after he brought down substitute Shanyder Borgelin in the final minute.



Martino said Suarez's performance had gone perfectly according to his plan.

"We had talked about him having half an hour and he defined the game," said the Argentine coach.

"One of the coach's tasks, with these players, is to convince them when to stop, when to allow themselves a break and not risk injury.

"I try to get them to make a contribution not only when they play 90 minutes but less, and boy, did he do that today."

Martino said Messi's rear-leg injury was being dealt with "week to week" and he refused to be drawn on his potential involvement in Argentina's upcoming friendlies.

"It is clear that with him there is an objective that he can play in the quarterfinals of the CONCACAF Champions Cup. We're not going to take any risks," he said.

Miami will play Mexican club Monterrey in the regional competition on April 3.

The other backroom staff are former Ghanaian internationals John Painstil and Fatau Dauda.

Painstil, a former assistant coach at Kaizer Chiefs and a CAF License B holder, represented Ghana in two World Cups and was part of the squad that won bronze at the 2008 Africa Cup of Nations.

Dauda, a former goalkeeper, played for Voradep, Okwahu United, AshantiGold, and Orlando Pirates.

He earned 23 caps for Ghana and participated in the 2014 World Cup.

Addo returns after 15 months Addo, the strategist behind Ghana's victory over Nigeria in the 2022 World Cup playoff, returns after a 15-month absence.

This follows Chris Hughton's dismissal after Ghana's disappointing group-stage exit at the recent Africa Cup

of Nations.

The Ghana Football Association (GFA) awarded Addo a 34-month contract on Friday, with an option to extend for two more years.

His impressive performance during a rigorous interview process convinced the selection panel.

"Otto was exceptional and highly rated by the search committee," said GFA president Simeon-Okraku, according to CAF Online. "There were strong candidates, so the committee interviewed many to gather their insights."

Currently with Borussia Dortmund's coaching staff, Addo will be released for this international window before returning to Germany

The Black Stars will face Nigeria on 22 March and Uganda four days later, with both matches taking place in Marrakech, Morocco.

These friendlies will be an opportunity for Addo and his assistants to assess the Black Stars ahead of the 2026 World Cup qualifiers in June.

Unlike Ghana, Nigeria has yet to appoint a new coach since José Peseiro's departure at the end of February.

Reports suggest assistant coach Finidi George might lead the Super Eagles in the upcoming friendlies, possibly positioning himself for the permanent role.

Other former Nigerian internationals, including Emmanuel Amunike, Sylvanus Okpala, Samson Siasia, and Sunday Oliseh have also expressed interest in the head coach position.

Chris Wood had put Forest ahead, but Berry's 89th-minute strike ensured a share of the spoils.

Nigeria's Taiwo Awoniyi and Ola Aina did not feature for Forest in this match.

Also, Burnley boosted their survival hopes with a crucial 2-1 victory over Brentford.

This win marks their first Premier League triumph of 2024.

Frank Onyeka played for 59 minutes for Brentford, who remain precariously close to the relegation zone, just four points clear of 18th-placed Luton Town.

Burnley still have a significant climb ahead of them, sitting eight points from safety in 19th position.

Last week, we read how the signs are not looking good for a nation like ours that wants to be reckoned with internationally. We concluded by asking the federal government to look at ways to reduce the cost of governance and the unimaginable take-home pay of political leaders and redirect the excess towards production. And we emphasised that we must become a productive nation that eats, drives and wears what it produces.

We also exhorted anyone genuinely interested in the welfare of workers, and of Nigerians, to proffer solutions that would boost our economy and strengthen our currency and not suggestions that would bastardise our economy and drive the naira's value further down. And that salary increase at the moment will not help the economy.

The federal and state governments must also, as a matter of urgency, resuscitate moribund industries dotted across the landscape so as not to only galvanise production but to improve locally generated revenue. And because millions will get direct and indirect jobs if the moribund industries dotting all over the country become alive, the production of local materials will be boosted as there will be more buyers, leading to more employment

Government, and here I mean the federal and state governments, must always be truthful and fair to the citizens. They must also make their agencies work. The government must let government function. In almost all cases, it is the government that makes government fail because the actors do everything from a prism of personal gain. Nothing about service anymore. Then there is the Nigerian syndrome of "Do you know who I am?"

I will give you an example. Just recently there was a furore that the Presidential Villa owed the Abuja Electricity Distribution Company N923 million, the Nigerian Police owed N1.4 billion and the office of the Central Bank Governor, N1.6 billion. Put together, the federal government and its agencies were indebted to the tune of N47billion. And, you see, God save any AEDC official who tries to disconnect power from Villa, Police Headquarters or CBN

But every year there is money for the payment of NEPA bills in the government and its agencies' budgetary allocations, so why should the bills accumulate? If the power company has not been paid, where

did the appropriated money go? Is the government here not strangulating the electricity company with its hand, yet every day we cry of epileptic power?

It is commendable that President Bola Ahmed Tinubu ordered the immediate payment of the Villa bill; however, is it enough without instituting an investigation into the failure of the Villa bureaucracy to pay its electricity bills despite budgetary provisions? This is the sort of thing that would make Nigerians sit up and take note. Otherwise, it is just the old system: sweep the sleaze under the carpet and let sleeping dogs lie.

Perhaps, because citizens, rightly or wrongly, think those in authority would naturally dip their hands into the treasury, and also scramble (as the Europeans scramble for Africa) over state resources, that is why some of them scramble over any resources close to them. Maybe this is why any warehouse they see, any trailer load of food that enters their 'trap', they pounce on it. And do you blame them when they refuse to pay NEPA bills?

Every day something new is trending. Yesterday it was budget padding; today it is "each senator got N500million." Who knows what tomorrow will bring? The citizens must feel that their interests are also part of the mix. That sense of belonging would automatically bring down the crime rate substantially.

Governance must be accorded the seriousness it deserves. When you go through our budget and the imputed figures, like a template across the MDAs, one would

be forgiven to think that governance is a joke and budget implementation is akin to sharing the national cake within an anointed group.

Justice and fairness must permeate the land. No nation can rid itself of crime as long as its leadership does not go out of its way to give the people a sense of belonging and fairness, and its judiciary fails to give protection to the oppressed.

Therefore, leaders at the centre must be exemplary, which will make those in charge of other tiers of government follow suit. It is not enough for a leader to be mouthing platitudes while his actions go contrariwise. This is what is meant by "Change must begin with the leader" where the Brazilian lyricist and author of The Alchemist, Paulo Coelho, said, "The world is changed by your example, not by your opinion."

I will never get tired of hammering it - to all who care to listen - what Sheikh Usman Dan Fodiyo wrote in his book, Bayan Wujub al-Hijrah alal ibad: that "the death of a thousand good men is not as tragic as having an unfit man in a position of national leadership and that "a kingdom (nation) can endure with unbelief, but it cannot endure with injustice."

To ensure that justice is served, we must strengthen our legal and judicial systems. We need to reform our laws and improve the capacity and independence of our judges and lawyers. This will earn the system more respect and bring back the trust of the people that has been heavily eroded.

These, and more along this line, are the things our leaders must do to make our country the great nation it is meant to be. Every leader will be proud that under his watch we became a united people and forged ahead to become an industrialised nation.

Another reason I always look at some Nigerians from the south and north who shout "Let Nigeria be divided" and shudder. Do they know what they are saying? Do they think that that is feasible anymore? Would it be beneficial to all concerned? We will look at this next.
